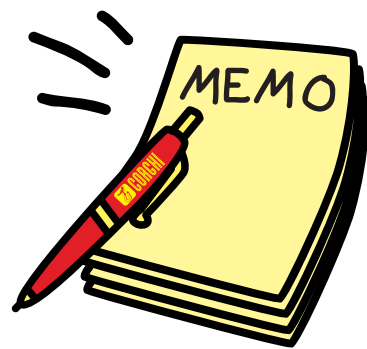


Product bulletin
